How to Book: Booking form must be completed, signed, and returned with a 30% of the trip deposit before any booking can be accepted. Since we specialize in custom, small trips, and have limited spaces we highly recommend that you book a trip at least six months in advance. Also most airlines give their cheapest airfares months in advance. Upon receiving your deposit we will send you a detailed trip itinerary, equipment and clothing list, medical information, and general information to prepare you for the trip. Final payment is due sixty days prior to your departure. Bookings made within sixty days of the departure date must be paid for in full at the time of booking. Please print or type all the information needed on the booking form. Please include two passport size photos. Send your check to Diego Buzzurro.

Cancellations and Refunds: Achala Outfitters reserves the right to cancel any trip prior to departure for any reason whatsoever, including insufficient sign-up or logistical problems that may impede trip operations. We make advanced payments for ground operations to our agents. If there is a cancellation due to an act of God, war, labor

strikes, earthquakes, etc., Achala Outfitters will refund the portion of the trip cost not advanced to suppliers and use whatever means possible to recover and refund the balance as promptly as possible. However, Achala Outfitters does not guarantee recovery of any or all of the advanced payments made. Achala Outfitters is not responsible for expenses incurred by the trip members in preparing for a trip that cancels including: airfare, visa fees, equipment, inoculation, etc. Furthermore, Achala Outfitters will not be responsible for the expenses of any early arrivals: hotels, meals, transportation, etc. Once you have been confirmed on a trip that requires a medical certificate signed by a doctor, normal cancellation penalties apply if your doctor does not sign the certificate. All cancellations must be in written form in order to claim any refund. The deposit is fully refundable up until 60 days prior to date of departure.

Insurance: All the trip participants must have health insurance for accident, illness, injury, and helicopter evacuation insurance showing such insurance to Achala Outfitters. We highly encourage you to purchase trip cancellation insurance in the case that you have to cancel your trip due to personal or family illness, or death. You might also consider purchasing travel insurance which covers lost or stolen luggage, or other personal items.

Price includes: All lodge accommodation, all meals as per the itinerary, transportation and transfers as per the itinerary, permits and park fees, fishing licenses full crew, (cook, guides, kitchen crew, and insurance for the local staff), boat charter, western leaders, extensive first aid/trauma kit,

Price excludes: International air tickets, visa fees, inoculations, travel insurance, emergency rescue insurance, airport taxes, personal clothing and equipment, excess baggage charges, alcoholic beverages, and gratitudes,

Accommodation: All accommodations are based on a twin shared basis and they are included in the price. If you are traveling alone and are willing to share a hotel room or tent, we will try our best to pair you up with another trip participant with the same gender. If a single room is requested, single supplement will be added to land cost.

Expedition Member's Responsibility: Members of all tours have the responsibility to select a tour or an expedition that fits their abilities and interests. In order to assist you we grade the difficulty of each tour. We can also provide you with the names of past participants who can describe their experiences with us to you. Achala Outfitters ensures that the safety and comfort of our participants are the first and highest priority. Although we carry a basic first aid/trauma kit with us and all of our guides are trained in basic first aid, you must be aware that medical facilities for serious problems are often unavailable in the remote areas we visit. Evacuation can be prolonged, difficult, and expensive. Tour members are held responsible for being in sufficient good health to undertake the trip it is vital that persons with medical problems notify Achala Outfitters two months prior to date of departure. We strongly recommend a visit to your doctor and dentist before your trip. All members are responsible for preparing for the tour by studying the itinerary and pre-departure information packets sent by Achala Outfitters, and for bringing the appropriate clothing and equipment as advised on the list.

Limitations of Liability: Achala Outfitters and its owners, outfitters, agents, and employees give notice that they act only as the agent for the owners, contractors and suppliers providing means of transportation, hotel accommodation, restaurants, and all related services. Achala Outfitters shall not be liable for: (a) injury, loss, damage to person, death, any connection with any services resulting directly from: Acts of God, civil disturbances, strikes, terrorism, thefts, expense, inconvenience, failure of any means of conveyance to arrive or depart as scheduled, government restrictions over which it has no control, (b) expenses for hotels and meals incurred due to delays beyond our control. Achala Outfitters reserves the right to change the arrangement for any or all accommodations and the trip itinerary throughout each trip. Achala Outfitters reserves the right to give authority to all trip leaders to remove any client that might have some kind of undisclosed medical condition or any person who may jeopardize the comfort and well-being of the participants. Furthermore we reserve the right to use any or all photographs taken by our personnel in conjunction with our trips in our publications.

ASSUMPTION OF RISKS, RELEASE, AND GUARANTEE

You are required to sign this assumption of risk agreement in order to join one of our trips with Achala Outfitters (Please read this carefully, it is a legally enforceable waiver of rights.)

I, _____ understand and I am aware that during the tour or trek in which I have voluntarily applied to participate under the arrangements of Achala Outfitters and its agents, associates, or employees, certain risks, dangers or problems may arise, including but not limited to: the hazards of traveling in remote and mountainous terrain, accident, high altitude or illness in remote places without the availability of medical facilities, or means of rapid evacuation; the forces of nature; terrorism; roads, trails, hotels, boats which are not operated and maintained at standards common in the United States. I further understand and accept that due to the nature of terrain and travel to the foreign countries and also due to the political instability and poor tourism infrastructure existing in foreign countries, the tour I intend to undertake under the arrangements of Achala Outfitters and its agents or associates may fall short of my expectations. I accept and agree to assume all risks associated with the journey and further agree to abide by the terms and conditions of Achala Outfitters as described here in its brochures and publications. And in the event of illness, injury, accident, death, political, and other factors beyond the control of Achala Outfitters, its agents, associates or employees, I will not hold Achala Outfitters its agents, associates, or employees responsible or liable for damages. I understand and I travel at my own risk.

I understand that no refund is permissible once the tour is actually launched and is aborted or abandoned for whatsoever reason. However, in special cases appropriate refunds will be considered for services not rendered or missed as a direct result of ground handling agent or associates. Under such circumstances refund claim will only be limited to actual cost of the relevant services. Should any legal dispute arise from any incident whatsoever, I agree to all the following terms and conditions. 1) That any or all litigations will take place in Argentina within Neuquen Province. 2) That all proceedings will adhere to Neuquen Province Law in Argentina. Finally, I agree that if any recovery be awarded it will only pertain to the land cost of my trip with Achala Outfitters. I have carefully read, fully understand, and further accept and agree that the decision of Achala Outfitters pertaining to cancellation and refund policies, and limitations of liability is final and I shall not seek legal action against Achala Outfitters.
